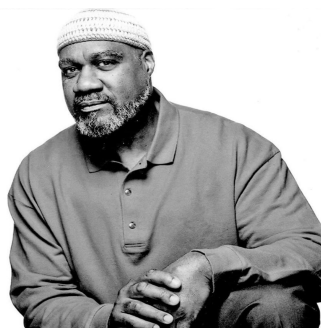


## THE NATIONAL JERICHO MOVEMENT NEWSLETTER (Vol. (1), Jan 2018)



Revolutionary Greetings.

There have been continued initiatives to raise the profile of U.S. political prisoners at the United Nations. In 2016, Jihad Abdulmumit, the current Chairperson of Jericho, made a presentation in Geneva, Switzerland on behalf of U.S. political prisoners. Jihad was a member of the Black Panther Party and BLA and a former political prisoner; he understands this struggle to forge a determination to free U.S. political prisoners. In 2018, the Jericho Amnesty Movement will reach a milestone of 20 years of actively fighting on behalf of U.S. political prisoners. In these nearly twenty years, Jericho has established a medical committee to assist political prisoners in their health needs; a legal defense committee to assist political prisoners in their legal defenses and challenges; assist families of political prisoners to visit, and continue to fight for their release...." ## Political Prisoner's/Prisoner's of War:

The Jericho Movement is saddened to report that our beloved comrade **Richard Mafundi Lake** joined the Ancestors on January 21, 2018. Mafundi was found on the floor of his cell on that day at 1:15 pm. and was pronounced dead of natural causes shortly thereafter. His wife Carolyn says that Mafundi suffered from various health conditions and had suffered three strokes in the past. Richard Mafundi Lake, Family hour was on Saturday, January 27, 2018. Survivors are loving wife, Carolyn Lake; children, Dr. Vanessa Anderson, Richard (Janice) Harris, Sonya (Patrick) Lloyd, Clinton (Vanessa) Hagler, Assata Lake, and Maia Lake; sisters, Veronica Lumpkin and Theda Craig; and brother, Stephen Lake. Mafundi's decades of schooling the youth in Alabama prisons makes him the progenitor of the Free Alabama Movement and the current, burgeoning prison abolition movement across the country. There will be a public memorial for Richard Mafundi Lake on March 3, 2018 in Birmingham, Alabama.

### 1-Medical:

**Leonard Peltier:** It is very cold in the facility. People are wearing coats to visit and the Prisoners aren't allowed to wear long sleeve or sweaters in the visiting room. Additionally, Leonard is still having great issues and pain with his prostrate, knee and hip problems, and nothing has been addressed adequately. Leonard asked his supports to write to:

Request that Leonard be given an operation for his Prostate Problem. Leonard saw a specialist 2 years ago for the problem and was informed that the procedure only takes 10 to 15 mins. The Dr. recommended Leonard have the procedure done, and Leonard has requested the surgery, but nothing has been done. Leonard said his enlarged prostate is causing him increased pain and discomfort. Also, on the health front we are still waiting for Leonard to get relief on his hip and knee problems.

**Mumia Abu Jamal**-Mumia is currently dealing with a very severe skin problem which is causing intense itching, cracking and bleeding of his skin. It has affected a great portion of his body. It is so severe, he has told his wife "I can't take it anymore". Because of this condition he cannot sleep. He is also concerned about neuropathy and cirrhosis of liver.

### **Please make 3 phone calls to demand healthcare for Mumia**

If you're sick, you can go to a doctor or an emergency room to be examined and treated, in a hospital if necessary. If you're being held behind bars, getting sick can be a death sentence. Profits come before prisoner care for the Dept. of Correction's medical contractors.

SCI Mahanoy political prisoner Mumia Abu-Jamal needs your help in getting treatment for a severe skin disease so bad he told his wife Wadiya he "can't take it any more." For more than 2 years, he has suffered from intense itching all over his body. The treatment for hepatitis C which we fought for and won has not cleared up his severe skin conditions. He is also concerned about his cirrhosis of the liver and neuropathy. People suspect tainted water may be causing problems for many prisoners.



Mumia and recent visitors report he can't sleep because the itching is so overpowering and relentless. His condition is worsening: his back, chest and arms have become rough and leathery, alligator-like. There appear to be hairline cracks in his skin that show bleeding.

Instead of a hands-on exam by an expert dermatologist, the DOC's doctor had a teleconference with Mumia, after which Ultra Violet (UVB) treatment and Dupixent were recommended.

Mumia stopped unsupervised, self-administered UVB treatment last year because his skin got burned. Mumia's UVB treatment should be safely administered at a hospital with a Narrow Band UVB, reducing the risk of burns and is more effective than Broad Band UVB.

Mumia needs a full diagnostic work-up before he receives a new medicine like Dupixent, which can have serious side effects if administered incorrectly outside of a hospital setting.

Mumia has been unjustly imprisoned for 36 years. The DOC's continuing failure to effectively diagnose and treat this severe skin disease is nothing less than torture and is one more reason Mumia should be released from prison, now.

**Seth Hayes**- Seth is still having trouble with his pump and the calibration. Robert Seth Hayes was taken to the Albany Medical Center-around December 30-or January 1<sup>st</sup> on an emergency basis. He was there for several days. When he returned to Sullivan he feeling much better. Basically, Seth's sugars were sky high, so they took him off the pump temporarily at Albany Med Ctr and

then reintroduced the pump after making various adjustments and stabilizing his sugar levels. However, he is still having trouble with his pump and the calibration.

**Kevin "Rashid" Johnson #158039**

**Kevin "Rashid" Johnson (#158039) wrote an article** about the Florida prison strike, which was published online on January 9, 2018. The following day warden Barry Reddish retaliated against Kevin's use of his First Amendment rights, ordering that he be given a disciplinary infraction for "inciting a riot". Further, on January 19th Johnson was thrown in a cold cell, with a broken toilet, no heating, and with a window that will not fully close, allowing cold wind to blow into the cell. The cell has the same temperature as the outside, where temperatures have been repeatedly at or below freezing. We have not heard anything from Kevin since January 19th. Warden Barry Reddish must be held accountable for illegal retaliation and, now, the torture of Kevin "Rashid" Johnson. We demand that Johnson is moved to a safe and clean cell, with normal indoor temperatures and with a toilet that works. We demand that Johnson be allowed to call his attorneys immediately. We demand that warden Reddish and all other Florida Department of Corrections officials stop retaliating against Kevin for his reporting on conditions in their prisons".

He is better now but it is extremely cold within the prison and during the cold snap here in Florida he had to get extra blankets to keep warm. The coldness extends to the visiting area where the visitors often wear sweaters or jackets and Leonard and other prisoners have on short sleeved jumpsuits. The prisoners are Not even allowed to wear long sleeve undershirts or sweatshirts to stay warm in the visiting area for security reasons the guards say.

**Birthdate: January 14, 1937 Sundiata Acoli:** is a Black/New Afrikan Political Prisoner of War. A tireless worker for Black Liberation, Sundiata was a prominent member of the New York State Chapter of the Black Panther Party. After acquittal from the NY Panther 21 Conspiracy Trial Frameup and being continually targeted by the FBI's illegal COINTELPRO operation, Sundiata continued the struggle underground with the Black Liberation Army. In 1973 he, Zayd and Assata Shakur were ambushed by New Jersey state troopers. Zayd Shakur was killed, while Assata was seriously wounded and taken into custody. One state trooper was killed in the attack and another injured. In a political charged and biased trial Sundiata was sentenced to life plus 30 years. In 2010 Sundiata was denied parole, but the fight for his freedom continues.

**Birthdate: January 14, 1948 Herman Bell:** is a former member of the Black Panther Party framed for the murder of a police officer in New York and is serving 25 years to life in prison. Herman Bell was born in Mississippi and moved to Brooklyn, New York as a boy. He was a talented High School football player and won a football scholarship to the University of California in Oakland. While in Oakland, Herman joined the Black Panther Party and became active around human rights issues in the Black community. In 1971, he went underground because of relentless FBI attacks on the Black Panther Party. While underground, Herman joined the Black Liberation Army, and in September of 1973 he was captured and extradited to New York on charges of having killed 2 New York City police officers— a case for which Jalil Muntaqim and Nuh Washington were already serving time. No witnesses were able to put Herman at the scene of the crime. The first trial ended in a hung jury and he was convicted at his second trial and given 25 years to life.

**Birthdate: February 4<sup>th</sup>, 1946 Veronza Bowers Jr.** is a former Black Panther Party member framed for the murder of a U.S. Park Ranger. He is being illegally held past his 30 year sentences, making him one of the longest-held political prisoners in U.S. history. Unjustly convicted in 19 of this murder on the word of two government informers, both of whom received reduced sentences for other crimes by the Federal prosecutor's office. There were no eye-witnesses and no evidence independent of these informants to link him to the crime. At his trial, Veronza offered alibi testimony which was not credited by the jury. Nor was testimony of two relatives of the informants who insisted that they were lying. The informants had all charges against them in this case dropped and one was given \$10,000 by the government according to the prosecutor's post-sentencing report. Veronza has consistently proclaimed his innocence of the crime he never committed, even at the expense of having his appeals for parole denied, for which an admission of guilt and contrition is virtually required, he insists on maintaining his innocence

**Birthday: February 19, 1953** **Kamau Sadiki** is a former member of the Black Panther Party and was convicted of a 30-year old murder case of a Fulton County Police Officer found shot to death in his car outside a service station. Kamau joined the Black Panther Party and began the struggle for his freedom at the age of 17 by dedicating his life to the service of his people. He worked out of the Jamaica, New York office of the Black Panther Party. A rank and file party member, Kamau worked in the Free Breakfast Program each morning and then went out into the community to sell the BPP newspaper later in the day. While selling his papers he continued to educate the people, while organizing tenants, welfare mothers, whomever he came in contact. At the end of the day, he reported to the office. He wrote his daily report and attended political education classes.

At 19 Kamau became a member of the Black Liberation Army (BLA). Several members of the BLA, including Kamau, left New York City and lived in the Atlanta area for a short period of time. On November 3, 1971 Atlanta Police Officer James Green was murdered. On the night of the murder, two witnesses observed three black males run from a van where Officer Green sat at a gas station in downtown Atlanta. Both witnesses failed to identify Kamau from a photographic line-up and there was no physical evidence that implicated Mr. Sadiki. In 1971, the Atlanta police department closed the case as unsolved. Then in 1999, the FBI in pursuit of collaboration in their attempts to recapture Assata Shakur, a political exile in Cuba, threatened Sadiki with life in prison if he did not assist them. When Sadiki did not comply the FBI convinced Atlanta police to re-open the case and charge Sadiki. In 2001, an alleged former BLA member gave a statement about the 1971 murder after being detained during a traffic stop. With no eyewitness testimony and no physical evidence, the State based its case entirely upon the statements of three alleged BLA members who were present in Atlanta at the time of Officer Green's murder.

In 2002 Kamau was finally arrested again in Brooklyn, New York some thirty one (31) years later after the murder; And then on November 10, 2003, Judge Stephanie Manis sentenced Kamau Sadiki to life imprisonment for murder and ten (10) years to run consecutively for armed robbery after a Fulton County Superior Court jury found him guilty for the murder of Atlanta Police Officer James Green on November 3, 1971

**Chubbuck, Byron Shane (Oso Blanco) #07909-051**

**Birthday: February 26, 1967** **Byron Shane "Oso Blanco" Chubbuck:** is an Indigenous rights activist & Native American Political Prisoner of War who was labeled "Robin the Hood" by the FBI for repeatedly expropriating funds from banks, only to give the money to folks in the hood. Based on the testimony of a confidential informant Oso Blanco was also accused of robbing banks in order to acquire funds to support the Zapatista rebellion in Chiapas, Mexico throughout 1998-99. Currently serving 80 years for bank robbery, aggravated assault on the FBI, escape and firearms charges in Lewisburg, Pennsylvania, Oso Blanco is unwilling to renounce his revolutionary politics and is periodically attacked and tortured by guards. **Ka'bah, Abdullah Malik (aka Jeff Fort) #92298-024**

**Birthday: February 20, 1947** **Ka'bah, Abdullah Malik "Jeff Fort":** was born on February 20, 1947 in Aberdeen, Mississippi and later moved to Chicago, Illinois with his family, residing on

Blackstone Avenue. In 1966, he assumed command of the Blackstone Rangers street gang and by 1968 he renamed it to The Almighty Black P. Stone Nation which had, under his leadership, become the largest and most powerful street organization in Chicago. It was during this time that he first became victim to a failed FBI COINTELPRO plot to forge a Chicago street war between The Stones and the Black Panther Party which was under the leadership of Chairman Fred Hampton who was shortly murdered by the Chicago Police in another COINTELPRO plot. In 1968, the FBI, under COINTELPRO, continued its campaign as the Stones federally funded teen jobs program came under investigation amid accusations that grant money was diverted to criminal activities and Fort was subpoenaed to testify before a Senate committee where he introduced himself at the committee hearings and walked out; for this, he was first convicted of contempt of Congress and then in 1972 finally convicted of misusing federal funds and sentenced to five years in prison. During his time at USP Leavenworth, he converted to Islam and assumed the name Prince Malik. After his release from prison in 1976 he joined the Moorish Science Temple. In 1978, he returned to Chicago and renamed the Black P. Stones to the El Rukn Tribe of the Moorish Science Temple: El Rukn being Arabic for pillar. Once again the FBI made moves on his organization as he was convicted in 1983 of drug trafficking charges and sentenced to 13 years in prison. He was sent to the Federal Correctional Institution at Bastrop, Texas where it is alleged that he continued to lead El Rukn through daily telephone calls from prison in order to instruct members of El Rukn to meet with Libyan officials and agree to commit terrorist acts in the U.S. in exchange for \$2.5 million. In 1987, by use of COINTELPRO type methods, he was tried and convicted for allegedly conspiring to transport explosives and conspiracy to commit violent acts of domestic terrorism in the United States on behalf, at the direction, or as representative of the Government of Libya. He was sentenced to 80 years imprisonment and transferred to the USP Marion, the federal supermax prison in Marion, Illinois. In 1988, he was also convicted of ordering the 1981 murder of a rival gang leader and was sentenced to 75 years in prison to be served after the completion of his terror conspiracy sentence. He was transferred to the newly opened ADX Florence supermax underground prison in Florence, Colorado in 2006 and remains there as of 2012, being under a no human contact order since his arrival.

We are very excited about our 20<sup>th</sup> anniversary as it marks two decades of ongoing commitment and struggle. Please see the powerful article written by The National Jericho Movement Chair and former Political Prisoner, Jihad Abdulmumit:

“The Jericho Movement to Free All Political Prisoners (now more commonly known as the National Jericho Movement) was started by Safiyah Bukhari (d. 2003), Herman Ferguson (d. 2014) and Jalil Abdulmuntaqim, who is a Black Panther political prisoner incarcerated for over 44 years. Jericho has maintained a steady course for 20 years. Beginning with its famous march on Washington in 1998, Jericho has continued to campaign to free freedom fighters, community activists and revolutionaries primarily from movements of the 1960s and ‘70s.

As time passes from decade to decade, one of the most difficult challenges facing Jericho is maintaining the continuous process of education of communities across the United States to the realization that political prisoners actually exist in this country. As movements come and go, racism and oppression remain; as well as those who have stood and fought against injustices, exploitation, and police and state sponsored violence remaining in prison for decades. Federal and state government, academics and media have done a stellar job in minimizing, misrepresenting and erasing the history and context of domestic revolutionary movements.

Without any historical context and analysis, freedom fighters of the past are easily made to look as though they are no more than common criminals. As a matter of fact, all revolutionary movements have been made to appear as such. Therefore, a profound nexus between movements and struggles past and present is the realization and support for political prisoners.

As time passes from decade to decade, one of the most difficult challenges facing Jericho is maintaining the continuous process of education of communities across the United States to the realization that political prisoners actually exist in this country. Support for political prisoners requires not just knowing, but doing. It requires action.

During the civil rights and national liberation struggle era, many revolutionary organizations, freedom fighters and community activists were victimized by the government’s counter intelligence program (COINTELPRO) unleashed by then FBI Director J. Edgar Hoover in the 1950s to disrupt the activities

of the Communist Party of the United States. In the 1960s, it was expanded to include domestic revolutionary organizations and militants, including members of the Black Panther Party, American Indian Movement, Revolutionary Action Movement, Young Lords and white anti-imperialists.

In its arsenal, the counter intelligence program employed tactics such as assassination of leaders, torture, Black propaganda, frame ups and imprisonment. It became a specific focused goal of COINTELPRO to ensure that no viable Black messiah or leadership arises to motivate and organize Black people toward freedom, justice and equality. In 1975 the Senate's Frank Church hearing declared COINTELPRO to be an illegal program. COINTELPRO continues today under many names, all of which now are perfectly legal.

It's unconscionable for activists and human right organizations today to overlook or abandon those who have sacrificed their lives for the movement and who languish in prisons for 30, 40 and 50 years! It is the responsibility of all conscious people, activists and human rights organizations to become informed about political prisoners and to realize that political arrests and incarcerations continue till this day. It is one of the state's natural and historical repressive responses to those who fight for freedom, justice and the right to self-determination.

There are dozens, perhaps hundreds of political prisoners in the United States. Most notable are those who have come from socio-political movements, such as Mumia Abu Jamal, Leonard Peltier, Dr. Mutulu Shakur, Sundiata Acoli and the remaining MOVE members, just to name a few familiar names[i]. There are also those who have become political while in prison, akin to the life experience of the renowned revolutionary, George Jackson, assassinated Aug. 21, 1971, in San Quentin Prison. Then there are those cases that are political, not because of the conscious level of the person involved, but because of the racism inherent within the institution of policing and the judicial system itself. When all of these factors are considered, the United States does indeed have thousands of political prisoners.

Support for political prisoners requires not just knowing, but doing. It requires action.

Jericho has local chapters across the United States. Some of its activities include actively maintaining direct communication with each political prisoner by visiting and writing them; providing financial assistance to them and their families as needed and when possible; advocating for their increasing medical needs, particularly as everyone gets older; working on amnesty campaigns – legal and political; educating people and communities across the United States with the strategic objective of building a mass movement to free all political prisoners; and building working alliances and coalitions with other like-minded people and organizations.

Uniquely, Jericho establishes communication with each political prisoner it represents so that they have a direct say in the direction of the organization.

Recently, political prisoner Jalil Abdilmuntaqim called for an international initiative named "In the Spirit of Nelson Mandela." This initiative will appeal to the international community, including the International Commission of Jurists, to call for special hearings within the United Nations to review the cases of political prisoners in the United States.

This initiative will reveal to the world the continuing historical conditions of racism, political repression and economic exploitation of the masses of people, particularly Black people, and acknowledge the gallant fight of scores of revolutionaries in building a society free of racism, exploitation and oppression. It will declare the continued incarceration of those who fought against these conditions as political prisoners whose human rights have been violated and who deserve to be freed.

Jericho calls on and invites activists and human rights organizations throughout the United States to join in this strategic effort. This is the call made by El-Hajj Malik El Shabazz and those before and after him who stressed the importance of raising our socio-political abuses beyond that of civil rights and place them squarely on the international stage of human rights.

Jericho calls on and invites activists and human rights organizations throughout the United States to join in this strategic effort.

This is the call; this is the mission. Bringing the issue of political prisoners in the United States to the international stage will also serve to educate and connect international communities, organizations and governments to the history of U.S. repression and the peoples' liberation struggles for freedom.

On March 24, 2018, the Jericho Movement will celebrate its 20th year anniversary of the original march on the White House. The event will take place in New York City and will include dinner and speakers as well as conscious performers. Not only are we looking forward to celebrating this 20-year milestone but we are more importantly looking forward to honoring its founders, their families as well as all of our PPs and POWs who have been waiting on their freedom.

While we stay within the guidelines and missives that were originally created, we are also taking innovative steps and approaches which will put us in a more strategically conducive position to address our PPs' and POWs' needs in this politically charged climate. Although we've had some victories and some losses over the last 20 years, we remain committed to bringing home our beloved freedom fighters who sacrificed so much, yet are still trapped behind the prison walls.

As this is a monumental event for not only those of us in service to free our freedom fighters, it is also an anniversary of importance to our political prisoners who started this movement in the spirit of hope and determination. Freedom fighters, their families and loved ones who remember the March on Washington are counting on all of us to help bring them home.

We ask for your support to make this a successful and memorable event which will produce forward thinking as we honor the Jericho Movement's missives, our freedom fighters and their families as well as all those who have fought alongside of us in seeking their rightful freedom. Many Jericho meetings occurred during the month of January across the nation to discuss the campaign "in the Spirit of Nelson Mandela, for political education classes, prisoner letter writing, organizing for various events as well as supporting affiliates and other organizations in shared missives. Jericho members participated in many forums this month as well as were keynote speakers at events.

The Jericho Movement initiated as well as participated in many calls to action this month. One important action was in support of Ahd Tamini. The Jericho Movement endorsed and joined the mobilization to free Ahd Tamimi on January 30. Jericho supports and participates in actions for Call To action on Puerto Rico! for the Puerto Ricans in the diaspora protest privatization and austerity measures in Puerto Rico among other causes and missives that align with freedom, self determination and ending oppression.

### **In the Spirit of Nelson Mandela Campaign**
