## CHAPTER REPORTS

### Detroit Jericho Chapter

-Attended two Free Mumia zoom meetings and several meetings of the Official Leonard Peltier Ad Hoc Committee. Urgent medical conditions for elders Leonard Peltier and Mumia Abu-Jamal prompted special meetings.

-We attended a Feb 8, 2024 book event for *The Trinity Of Fundamentals*:

-Written from Naqab Prison in 1993, *The Trinity Of Fundamentals* is the fictionalized account of former Palestinian prisoner Wisam Rafeedie's nine-year experience hiding from the Zionist Occupation. This story gives a glimpse into what life looks like when it is transformed by revolution and wholly dedicated to the cause of liberation.

-Confiscated by prison guards yet smuggled out of the Zionist prison by Rafeedie's comrades, it is now a significant text for the Palestinian prisoners' movement. Translated into English for the first time by the Palestinian Youth Movement! <https://1804books.com/products/the-trinity-of-fundamentals>

-Leonard Peltier: Helped create an informational brochure about Leonard for the Ad Hoc Committee; also putting out a call to action (for Feb 12, 14, 16) to demand elected officials get Leonard immediate medical care for his vision and his teeth.

-Mumia Abu-Jamal: Working on email lists to grow support around his serious medical situation. If anyone wants to be on a Mumia Updates list, email: [mumiafree2024@gmail.com](mailto:mumiafree2024@gmail.com) to get on the list.

-Josh Williams: In contact with and support of Josh Williams, a young political prisoner "from the uprising in -Ferguson", where he protested against police terrorizing and killing Black youth. Josh is a community activist, imprisoned based on unjust and trumped-up charges. He has served 9 years in a Missouri prison.

-Xinachtli (Alvaro Luna Hernandez): On January 10, 2024, Xinachtli communicated that several of the apps on his prison tablet were not working. He had been putting in the proper requests for it to be fixed, but was being ignored. This tablet is not only how Xinachtli communicates with the outside world, it's also how he experiences vibrant colors - color he is otherwise deprived of behind prison walls.

-Detroit Jericho put out several posts and email blasts (some of which were correction posts/emails because of typo errors on our part) and the People took action! People made calls and emails to various prison contacts, until on Feb 2, 2024 we got word that Xinachtli's tablet had been fixed! After his tablet issues were resolved, the next day, everything was NOT working on his tablet. He put a step one grievance in on Monday morning. Then, 3 tech people came directly to his cell and troubleshooted the tablet, and the tablet works now. But that's not all: the tech people stayed in the unit for around 4 hrs, and fixed all the tablets needing repair in the unit and replaced one! **From Xinachtli:** "Unity is key. We got to hold them accountable. Not only on the local and State level, but also on the International Human Rights level" Xinachtli

“Revolutionary activist Viola Plummer passed away on January 15th, 2024 at the age of 86. She was the last living founding member of the December 12th movement, a Brooklyn-based civil rights organization founded in 1986. Plummer is remembered for profound and dedicated work in the Black liberation movement. She used her voice for causes such as reparations, and was also involved internationally in the struggle against racism in countries like Zimbabwe, Venezuela, and South Africa.

Along with Sonny Abubadika Carson, Coltrane Chimurenga, Elombe Brath, and Father Lucas, Plummer founded the December 12th movement in 1986. The December 12th Movement fights racism, housing, reparations, criminal justice and education issues. Colette Pean, a member of the December 12th movement, described Plummer as “warm, direct, and firm” in her convictions. Sista’s Place is the realization of Plummer’s vision to

merge music with activism, Pean said. “It’s a devastating loss,” she said. “I think that her work will continue and that she left a strong foundation.” Plummer also was the Chief of Staff for both City Council members Inez and Charles Barron. “Viola Plummer was an activist 1,000% of the time,” said mTkalla Keaton, an artist who first met Viola in the late 80s. “There was something about Viola’s spirit and her demeanor that reminded people of Harriet Tubman, but at the same time, she had an incredible smile.” The funeral service for Plummer will be held on January 27, at House of the Lord Church at 415 Atlantic Avenue in downtown Brooklyn at 5pm.” Source: Email.

**PRESENTE! Original Philadelphia Chapter Black Panther Party Veteran  
Comrade Paula Peebles Has Joined The Ancestors**



**THE PHILADELPHIA CITY COUNCIL RESOLUTION TO BLACK PANTHER PARTY VETERAN PAULA PEEBLES**

“Honoring the life, work, and accomplishments of Paula Peebles, whose dedication to advocacy, organizing, and leadership has empowered Philadelphia’s movements for class and race equity.

WHEREAS, At a young age, Paula Peebles noticed glaring injustices in her majority Black North Philadelphia neighborhood: housing conditions were unacceptable, education was underfunded, and neighborhoods were segregated and under-resourced based on racial lines. Through the tutelage of her activist mother, Ms. Peebles would begin to implement her mother’s teachings to her passion for addressing these injustices; and  
WHEREAS, At the age of 14, Ms. Peebles led the first ever student walk out in the City. Students used the walkout as an opportunity to express displeasure for the superficial and general lack of Black history taught in their schools. Just two years later, during her senior year of high school, Paula Peebles became a member of the Black Panther Party at the age of 16; and

WHEREAS, Following this decision, Ms. Peebles would move into the Black Panther Community on her own. Ms. Peebles was a member of the Black Panther Party for five years. While there, she became a talented lay-out artist, so much so that Mayor Wilson Goode requested her skills to help him on his campaign trail. During this time in her life, Ms. Peebles learned how to administer sickle cell anemia tests and worked in the Black Panther Party breakfast club throughout her tenure as a member; and

WHEREAS, Paula Peebles remained a member of the Black Panther Party until she moved to Oakland, where she continued her activism and community organizing. Eventually, Ms. Peebles returned to Philadelphia to continue her fight against injustices at home. She graduated from Temple University in 1980 with a bachelors in Education. Later in 1985, Ms. Peebles pursued a masters in Community and Economic development from Southern New Hampshire University; and

WHEREAS, Ms. Peebles went straight to work after graduating, founding the Renaissance Community Development Corporation in 1979. She would later go on to serve as President and CEO of the organization, whose main goal was to provide low cost housing to low-income individuals and families, and to engage her community in the neighborhood's development. Ms. Peebles worked there for 38 years before she retired in 2017; and

WHEREAS, Ms. Peebles began to implement what she had learned into her aspirations. On October 25, 1997, dozens of women marched on the Benjamin Franklin Parkway to advocate for the story of being a Black woman in America. This massive event became known as the Million Women March, of which Ms. Peebles was a co-founder. Later in her life, Ms. Peebles became a professor at the University of Delaware, where she taught courses on community development from 2005-2012; and

WHEREAS, During this time in her life, Paula Peebles joined the National Action Network (N.A.N) in 2009. Because of her constant devotion to social justice, Ms. Peebles was brought to serve on the chair committee of the National Action Network for the Philadelphia chapter. She dedicated four years into serving this role, until she stepped down in 2015 so that she could found the Pennsylvania chapter of N.A.N, where she continues to serve as a Chairperson. In 2018, Ms. Peebles joined the Black Women's Leadership Council upon its establishment. A year later, in 2019, Ms. Peebles was a founding member of the Philadelphia Human Relations Council, and, a year later, became the Vice President of the Council; and

WHEREAS, As an activist, Paula Peebles supported Stadium Stompers in successfully preventing further encroachment into North Central Philadelphia by Temple University's plans to build a football stadium. In 2015, Cordish Corp began to set plans to build a large casino in South Philadelphia. Fraught with allegations of racist practices, Peebles helped file a lawsuit and bring awareness of these allegations. Furthermore, she organized several protests which stalled the project for two years; and

WHEREAS, In 2017, Paula Peebles helped organize several of the George Floyd protests in Philadelphia. Her leadership was instrumental in the successful organization of these protests, while guiding and protecting participants in the marches. A year later, Ms. Peebles joined groups calling for the abolishment of Philadelphia's tax abatement, which contributes to the rapid displacement of long-time residents in gentrifying neighborhoods; and

WHEREAS, Later in 2020, Paula Peebles finally saw the removal of racist mayor and police chief, Frank Rizzo's, statue. This accomplishment marked the end of a battle she had been engaged in since 2015, advocating for the removal of the statue which stood in front of City Hall since 1998. And just one year later, Ms. Peebles was already endeavoring in her next mission, supporting a law that would expand zoning boards from five to seven members. This law also mandated that community group leaders be included on these boards. This is just one of the many community development service that Ms. Peebles has been constantly involved in her entire life; and

WHEREAS, In a lifetime filled with contributions to our City, Paula Peebles has not forgotten her Black Panther roots. Today she serves as the Vice President for the National Alumni Association of the Black Panther party; therefore be it

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, that we hereby honor the life, work, and accomplishments of Paula Peebles, whose dedication to advocacy, organizing, and leadership has empowered Philadelphia's movements for class and race equity.

FURTHER RESOLVED, That an engrossed copy of this resolution be presented to Paula Peebles as an expression of the sincere respect and awe of this legislative body.

### Terry Bisson, Rest in Power



"It is with great sadness that I forward this news about the loss last week of a true fighter for justice, a great anti-racist, and a dear comrade, Terry Bisson, at age 81. In 1985, he was my partner in resisting a federal grand jury that ultimately swept up 6 white anti-imperialist above-ground activists, forcing us to choose between collaborating (aka snitching) or going to prison for contempt of court. It was never a difficult choice. Terry and I joined a long tradition of progressives, starting with Puerto Rican independence leader Juan Antonio Corretjer in 1936, who affirmed that we would never cooperate with an institution -- nominally a grand jury but actually a thin cover for the FBI -- that was hell-bent on the destruction of every movement we support for freedom, justice, and liberation. Terry and I made a great team -- all legal strategy meetings were held jointly -- along with our two fearless and brilliant movement attorneys, Michael Tarif Warren and Susan Tipograph. Tarif & Tip helped secure much-appreciated delays in the final "contempt" finding, thus postponing the date of our incarcerations in two different prisons.

There's much more about my relationship with Terry, including [a beautiful piece](#) he wrote in 1998 at my request for *POZ (HIV/AIDS)* Magazine about the now late Indigenous gay, HIV+ political prisoner Eddie Hatcher -- which I'll write about at a later date. For today, suffice it to say:

**-first**, that his partner Judy Jensen was a key force behind all of his accomplishments, and to whom I send my deepest condolences, and

**-second**, that his beautiful poem below, "RSVP to the FBI," which he wrote two months before both of our imprisonment in July 1985, was a tremendous inspiration to me, which I repeatedly read during my three months in prison and long afterward. Terry totally spoke for me with his eloquent words.

Rest in power, my beautiful brother. And thanks to Noelle for writing and sending this fitting tribute.

\*I was one of six members of the John Brown Anti-Klan Committee, three women and three men, subpoenaed to a federal grand jury investigating, not our work, but armed actions by comrades who were underground.

Following the example of Puerto Rican Independentistas (and most Leftists historically) we refused to cooperate and were for some months political prisoners.

Terry Bisson was many things: imaginative, southern born, grand jury resister, science fiction writer, member of John Brown Anti Klan Committee, proprietor of the New York City based Jacobin Books, anti-imperialist, erudite editor, short story writer, ghost writer, screen writer and beacon. I will never forget the image of Terry roaring up on his motorcycle, hanging back at the party, treating us to his droll and impish smile. I asked Terry for a favor once. I knew he had edited the impressive "Hauling Up the Morning" on Red Sea Press. It was 1994 and had to shop Mumia's essays to a major publisher. Terry said "there is only one agent for this: Frances Goldin, let's go see her". Frances in her inimitable style, said 'come to the Lower East side, my Apartment is 7F, I will listen'. When we had finished she said, "You have to put this all together go make the copies, I will do the cover letters... but don't expect anything, it is Aug. they are all on holiday." The next word we heard Mumia got a 30K advance and a hard cover contract with Addison Wesley for his first book "Live From Death Row"! Thank you Terry for writing, editing, connecting and imaging our future.

"Sekou Odinga was a globally recognized Black liberation activist, member of Malcolm X's Organization of Afro-American Unity, founding member of both the New York City chapter and the International Section of the Black

Panther Party, and former US political prisoner who survived 33 years of state captivity before his release in 2014.

Prosecuted as one of the “Panther 21” in New York City, Odinga was a prominent historical figure, having been featured on Democracy Now! and in numerous documentaries, concerts, mass public events, and major news outlets.

In addition to being featured in the widely circulated social movement texts *Can't Jail the Spirit* (2002) and *Hauling Up the Morning: Writings & Art by Political Prisoners & Prisoners of War in the U.S.* (1990), Odinga published his writing in *Look for Me in the Whirlwind: From the Panther 21 to 21st-Century Revolutions* (PM Press, 2017) and *Black Power Afterlives: The Enduring Significance of the Black Panther Party* (Haymarket Books, 2020).

A survivor of state torture and the FBI's notorious Counterintelligence Program (COINTELPRO), Sekou Odinga is both celebrated and admired by freedom and justice movements worldwide, exemplifying persistence, courage, and principled adherence to freedom struggle under the most repressive circumstances imaginable.”

### **U.S. Peace Council Joins the International Court of Justice in Condemning the Israeli Genocide against the Palestinians**

“We also call upon the Global North states to reinstate their aid to the UN Palestine Agency (UNRWA)”

“On January 26, 2024, the International Court of Justice (ICJ) released an order that found “plausible” evidence of genocide in Israel’s bombardment of the Palestinians of Gaza (paragraph 54). The ICJ, also known as the World Court, called upon Israel to “take all measures within its power to prevent the commission of all acts” that are genocidal (paragraph 78).

The ICJ ruling cannot be appealed. Israel has been given a month to cease its genocidal war. Meanwhile, Algeria has asked the United Nations Security Council to enforce this order.

This order from the ICJ demands an end to the Israeli violence, including the withholding of humanitarian aid. Although not explicitly named, the order implicitly applies to the full complicity of the U.S. in the genocidal war against the people of Palestine.

The US Peace Council welcomes the ICJ order. We call upon the people of the U.S. to demand:

1. That the U.S. government cease its support of this genocide. We support Defense for Children International in its case, brought to the federal court by the Center for Constitutional Rights, against the administration of U.S. President Joe Biden.
2. That elected members of the federal and state legislatures intervene in the public domain and in their elected bodies to impel the Biden administration to cease its support of this genocide.
3. That the U.S. government restart its funding for the UN Palestine agency (UNRWA), which – apart from other things – funds the education of half a million Palestinian children and funds the relief of all the residents of the Gaza Strip. U.S. Peace Council, January 29, 2023” Source: Email.

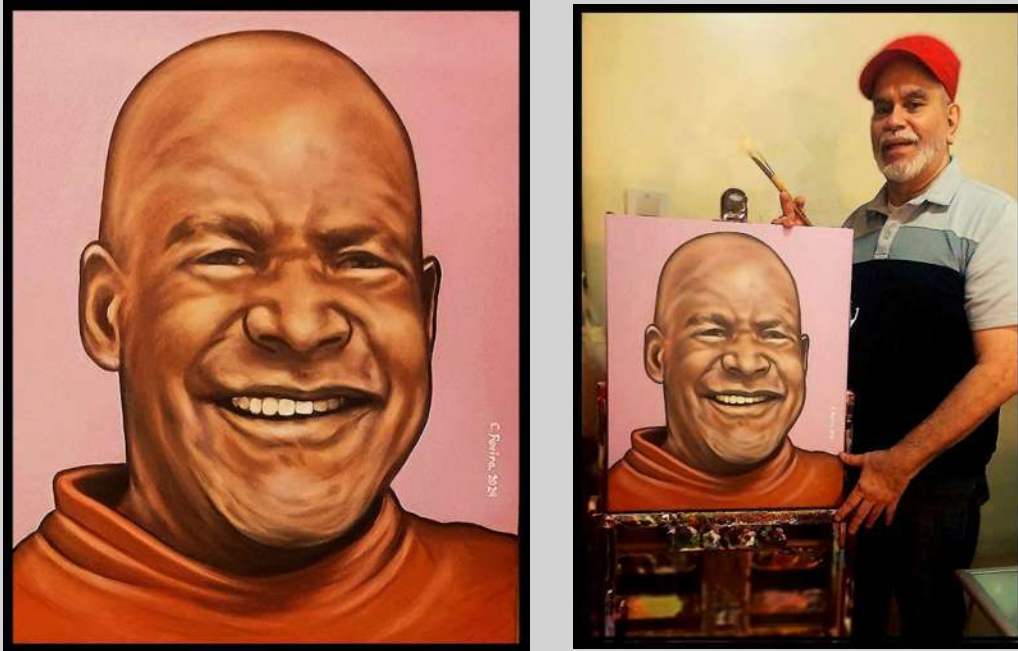

### **‘Dear Children of Gaza,’ Says Viral Letter, ‘I Am Sorry’ By Julia Conley**

“You may ask the world why there was swift action when trade routes and economic interests were at risk but deafening silence when 10,000 children were killed,” wrote a British lawmaker. “The world might not like your questions, but you deserve your answers.” In a viral video released Friday, British member of Parliament Naz Shah, who represents the Labour Party, issued an apology to the roughly 1 million children of Gaza on behalf of world leaders who—despite Palestinian journalists’ live-streaming of Israel’s assault on the enclave and an international court’s finding that Israel is plausibly committing genocidal acts—refuse to see the impact the bombardment is having on civilians, including its youngest residents.

The video shows Shah writing a letter addressed to the “children of Gaza,” along with images of children being treated in hospitals, buried under rubble, and living in shelters since Israel began bombarding the enclave in retaliation for Hamas’ attack on October 7. Children are also seen gathered on a playground prior to the air and ground assaults that have so far killed more than 13,000 children.

“We hear about your dreams and aspirations, to learn, to travel, to visit your beaches with clear blue water or play in playgrounds with swings and slides,” wrote Shah. “To become astronauts, teachers, and doctors. And every day we see how those dreams are no more.”

“You may ask the world, ‘Where were these international values of freedom, justice, and equality when the world could not even protect the right to life for a Palestinian child?’” she added. The letter was released the same day the International Court of Justice (ICJ) issued a preliminary ruling in South Africa’s case against Israel, in which the country argued Israeli officials and military officers have committed genocidal acts in Gaza. The ICJ found that South Africa’s case was plausible and ordered Israel to “take all measures within its power” to uphold its obligations under [Article II](#) of the Genocide Convention.

On Saturday, the Ministry of Health in Gaza [reported](#) that there had been 174 people killed in the enclave in the previous 24 hours.

The U.N. Security Council is [expected to meet](#) next Wednesday to discuss the ICJ ruling at the request of the Algerian government, which said it would give a “binding effect to the pronouncement of the International Court of Justice on the provisional measures imposed on the Israeli occupation.”

*Al Jazeera* reported that, according to diplomatic sources, Algerian officials are likely to call for an immediate truce.

Georgios Petropoulos, director of the U.N. Office for Humanitarian Affairs in Gaza, [told](#) the outlet Saturday that nearly the entire population—2.2 million people—is now at risk of starvation and the agency can meet the clean drinking water needs of just a third of Gazans.

“Everyone in Gaza needs aid now and the war must stop,” he said.

The ICJ ruling, [said](#) Shah, may give “hope to the children of Gaza. But without an immediate ceasefire we will be letting them down.”

The lawmaker’s viral letter was released nearly three months after about 20 children [held a press conference](#) outside Al-Shifa Hospital in Gaza City, asking world leaders to protect them.

Now, said Shah, addressing the children of Gaza, “you may ask the world why there was swift action when trade routes and economic interests were at risk but deafening silence when 10,000 children were killed, when your mothers’ hearts were torn and your fathers clung and kissed your lifeless bodies farewell... The world might not like your questions, but you deserve your answers.”

“The world sees your innocence and bravery, your suffering and endurance, and despite the horror, you still continue, with the world on your shoulders,” Shah continued. “Whilst we raised our voices, filled the streets, and called for an end, it was not enough. “The Black Alliance for Peace (BAP) seeks to recapture and redevelop the historic anti-war, anti-imperialist, and pro-peace positions of the radical Black movement.

The Black radical perspective sees the relationship of Black people in the United States through a much different lens than the fictional accounts of U.S. origin myths. The stark reality of the barbaric Atlantic slave trade, Indigenous land theft and brutal genocidal policies occupy the center of that perspective. The strategy of colonialist war, as well as systematic state and private violence, is what we see as the heart of the methodology for establishing and then maintaining the first White supremacist republic in the history of human societies. Indeed, the establishment of the United States with the ratification of the constitution in 1789 in the midst of the turmoil in France and the beginnings of the French revolution is not seen from the radical Black perspective as the dawn of a new day for human liberation in either country, but the continuation and re-consolidation of what Rodrick Bush called the “Pan European Colonial Project,” that vicious, hegemonic campaign that was fueled by the European invasion of the Americas in 1492.

Despite the high-sounding proclamations of liberalism and enlightenment thought that asserted the universal equality and inherit rights, systematic, extreme, unspeakable violence constituted the relationships between Europeans and the racialized “others.” For the Africans who ended up in the United States, not one decade of peace has existed between African descendants and white authorities.

With the growing maturation of the radical Black movement in the late 19th and early 20th centuries, the formal institutionalization of racial apartheid in 1896 with *Plessy v. Ferguson*, the beginnings of the Pan African movement, the Russian revolution, and agitation and organizing in Black urban colonies like Harlem (that

offered a precarious refuge for the first wave of escapees from the fascist totalitarian South), saw the creation of a solidarity movement among Black people in opposition to U.S. and European colonial violence.

From the opposition to fascism in Spain and the invasion and occupation of Ethiopia by Italy in the 1930s through the 1960s when leading black organizations like the Student Nonviolent Coordinating Committee (SNCC) sparked the anti-Vietnam War movement with their opposition to the war and their expression of solidarity with the Palestinian national struggle, Black anti-war and anti-imperialist positions reflected the Black internationalist stance at the center of the Black radical tradition.

In general, suspiciousness and skepticism—if not outright opposition—to U.S. militarism characterized much of the Black community’s views regarding U.S. foreign war policy until the ascendancy of the first Black president, Barack Obama.

During the Obama administration, a significant shift took place in the consciousness of large segments of the African American population. They became more supportive and uncritical on U.S. militarism and interventions. Many seem to be unaware or had forgotten Dr. King’s sharp denunciation of U.S. militarism and violence, and the historical opposition to U.S. imperialism that characterized much of the positions of the Congressional Black Caucus—pre-Obama.

Militarized policing, over \$4 billion worth of military hardware turned over to local police departments, extrajudicial murders (police executions), the school-to-prison pipeline, aggressive military recruitment of black and Latino youth, the normalization of militarism, and general popular support for the militarized strategy of U.S. global “Full Spectrum Dominance” provides the context for and impels the establishment of a Black Alliance for Peace.

The establishment of Black Alliance for Peace will be a first step in revitalizing the critical, moral stance on issues of war and state repression the Black population in the United States had historically embraced. BAP is part of the effort to rebuild the broader anti-war, anti-imperialist and peace movement.

By comprehensively linking the issue of state violence and militarism, BAP will concentrate its efforts on not only opposing the U.S. war agenda globally but the war and repression being waged on Black and Brown communities domestically.” <https://www.thejerichomovement.com/partners/black-alliance-peace>

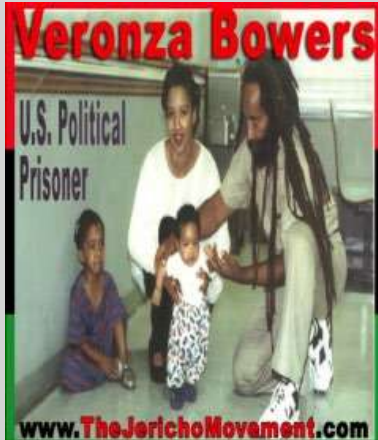

Veronza Bowers Jr. is an inmate at the Federal Medical Center in Butner, North Carolina. He is a former member of the Black Panther Party incarcerated in federal prison for over 46 years.

In the five decades of his confinement, Veronza has become a “model “prisoner. He is an author, musician, a student of Asian healing arts and has a strong interest in Buddhist meditation, as well as “hands-on” healing techniques which he practiced at the various facilities in which he has been

incarcerated. Veronza is also an honorary elder of the Lompoc Tribe of Five Feathers, a Native American spiritual and cultural group. He is a mentor and founder of the All-Faith Meditation Group, a non-denominational spiritual organization devoted to healing meditation using the traditional Japanese shakuhachi flute, which he has been blowing for over 30 years. Veronza is a member of the International Shakuhachi Society. In 1973, Veronza was convicted in the murder of a U.S. Park Ranger on the word of two government informers, both of whom received reduced sentences for other crimes by the Federal prosecutor’s office. There were no eyewitnesses and no evidence independent of these informants to link him to the crime. The informants had all charges against them in this case dropped and one was given \$10,000 by the government, according to the prosecutor’s post-sentencing report. Veronza has consistently proclaimed his innocence of the crime he never committed. Even at the expense of having his appeals for parole denied—for which an admission of guilt and contrition is virtually required—he insists on maintaining his innocence.”

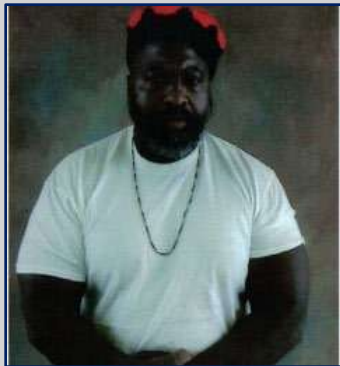

Kamau Sadiki is a father, grandfather, and Political Prisoner. He is also a veteran of the Black Panther Party, wrongfully convicted when the FBI, in their efforts to recapture Assata Shakur, convinced Atlanta police to reopen a 30-year-old cold case murder of a Fulton County police officer, and charge Mr. Sadiki.

The police told Kamau that if he worked with them and “got Assata to leave Cuba” and go to some other country where they could apprehend her, they would not

prosecute on the false police killing charge. The police offer was rejected, and Kamau, now serving a Life plus 10 years sentence, has always maintained his innocence.

Kamau Sadiki is now 70 and in poor health with Hepatitis C, cirrhosis of the liver, blood pressure issues, open infectious wounds and sarcoidosis. Every day is a struggle for him, and for his two daughters and grandchildren, who are devastated by the absence of their loving, hard-working father and grandfather, who supported them by working for the telephone company in New York for over eighteen years. 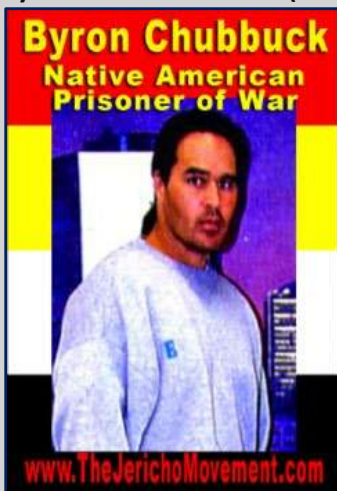

“Oso Blanco became known by the authorities as “Robin the Hood” after the FBI and local gang unit APD officers learned from a CI that he was robbing banks to send thousands of dollars to the Zapatista Rebels of Chiapas regularly during 1998 and 1999. He is now serving 55 years in prison for bank robbery, aggravated assault on the FBI, escape and firearms charges. Oso Blanco defended himself from federal agents in a gun battle on August 13th 1999 at his home in Albuquerque, New Mexico. Although he escaped, he was arrested later that day and sentenced to time in New Mexico’s state Penitentiary. After serving

just over a year in New Mexico, he escaped from a prison transport van and almost immediately began robbing banks. He was recaptured a short time later.

Oso Blanco never used a gun in any bank robbery, but he has a long history of living by the gun and will not hesitate to use it on the agents of repression or the occupiers of Aztlán who force false laws on the true people of this land. He is not asking for monetary support; he's only asking that people become aware of indigenous people's issues. In an interview he expressed "I am still able to hold my head up high and feel the gratification for my work in a world where money, power and destructive industries are regarded far above humanity, indigenous and impoverished peoples and cultures. I cannot help that I got deeply into my work...."

"We shall no longer kill Mother Earth and everything else just to have modern technologies and pay for death as tax slaves. We shall rise up refusing to be slaves to commerce and political lies, in our own Land."

"We shall be High master" – High master of the heart Realm of Higher Consciousness.

Captured 1972--8 Life Sentences--In prison 51 YEARS

The "Virgin Island Five" are a group of activists accused of murdering eight people in the U.S. Virgin Islands. The murders took place during a turbulent period of rebellion on the Islands. The island was put under virtual martial law, and eventually five men: Ismail Ali,

Warren (Aziz) Ballantine, Meral (Malik) Smith, Raphael (Kwesi) Joseph, and Hanif Shabazz Bey were apprehended and then charged with the attack. All the men were known supporters of the Virgin Island independence movement. The five were charged after being subjected to vicious torture in order to extract confessions. They were beaten, hung from their feet and necks from trees, subject to electric shocks with cattle prods, had plastic bags tied over their heads and had water forced up their noses by the "defenders of the law." The judge (Warren Young) overlooking the case worked as Rockefeller's private attorney and even handled legal matters for the Fountain Valley Golf Course prior to being placed on the federal bench. Eventually, the five went to trial in what became known as the "Fountain Valley" murder trial. This was an obvious Kangaroo Court and a mockery of any sense of a fair trial. On August 13, 1973, each of the five men were convicted and sentenced to eight (8) consecutive life terms. Today, Warren (Aziz) Ballantine, Meral (Malik) Smith, and Hanif Shabazz Bey are all confined in prison. Ismail Ali was liberated to Cuba via an airplane hijacking in 1984. Raphael (Kwesi) Joseph was granted a pardon by the V.I. governor in 1992. Six years later Kwesi was mysteriously found dead of poison-laced drug overdose, after it was said that he was about to reveal evidence that would have exonerated at least one or more defendants.

Abdul (Warren Ballantine) was 23 at the time of his arrest. Now in his 70s, he has several chronic health issues that are difficult to manage inside prison, including advanced cardiac disease, severe arthritis and degenerative disc disease with injury to the spinal cord. After suffering two massive heart attacks in 2016, he is often unable to do many simple tasks, including ambulating to the visiting room or the phone area to call loved ones. Of his time with the Awaken Mentoring Group out of Golden Grove prison, he recalls, "we were doing excellent and exemplary work... on many different occasions attending schools, youth rehabilitation centers and other places to enlighten children." He has support within the Virgin Islands and mainland U.S., and at his age and stage of health he is not at risk to recidivate and should be granted release so that his daughter can care for him."

The police officer was killed in the confrontation, and Bowen fled. After his capture and incarceration, Bowen became a Black Liberation Army combatant, defiant to authorities at every turn." "Joe-Joe was sent to the Federal Prison in Marion, IL, where he met up with other political prisoners and prisoners of war, such as Sundiata Acoli, Hanif Shabazz Bey and Ray Luc Levasseur. 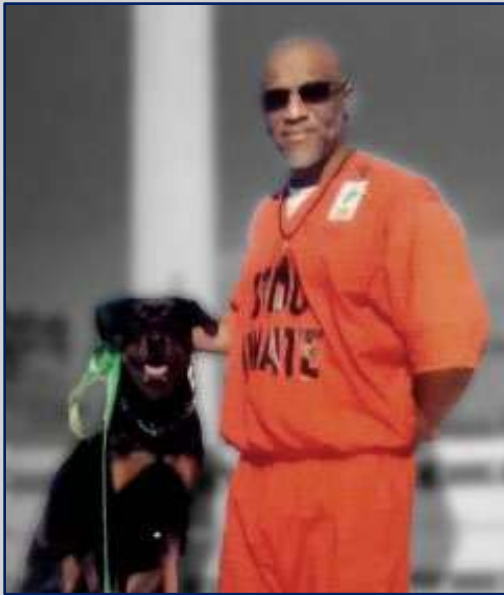

On April 14, 2023, Sundiata relocated to Turbeville Correctional Institution in order to further his experience working as a peer support specialist and to raise his chances of making parole by completing the ATU (Addiction Treatment Unit) Program at Turbeville. Upon completion of the ATU program, Sundiata will have



successfully completed the two highest substance use disorder programs for prisoners in South Carolina: Certified Peer Support Specialist and the ATU Program. Upon graduation, he will be assigned to duties that require aid in managing the ATU program as a certified peer support specialist.”

### Urgent phone zap for Red Onion Hunger Strikers Jan 23



"Since December 26, 2023, up to 30 prisoners in solitary confinement at Virginia's Red Onion State Prison have been on hunger strike to protest the continued use of torturous long-term solitary confinement. Despite critical concern, outcry from the public and prisoner populations in the state, incarcerated people are still subjected to this brutal practice which has been renamed "restorative housing" since July 1, 2023 when measures were passed to limit its use in the state.

Leading these prisoners in this effort is longtime prison activist, revolutionary writer and artist, Kevin "Rashid" Johnson. Rashid has stated that no one will take any food at all until demands are met. As of the last update from nearly a week ago, Rashid has been taken to the medical wing having refused over 63

meals and lost over 30 lbs. Furthermore, Red Onion prisonrats have formed a hungerstrike committee that is cutting off all communications possible including phone access, emails, visitation, and even legal calls. "We have to protect Rashid because he fights for all of us," said Shupavu wa Kirima, a leader of Rashid's outside support, on January 18. Rashid has reported on conditions at Red Onion for over a decade. Rashid and his comrades, several of whom also have chronic health conditions, are putting their health at risk to demand an end to sensory deprivation and torture.

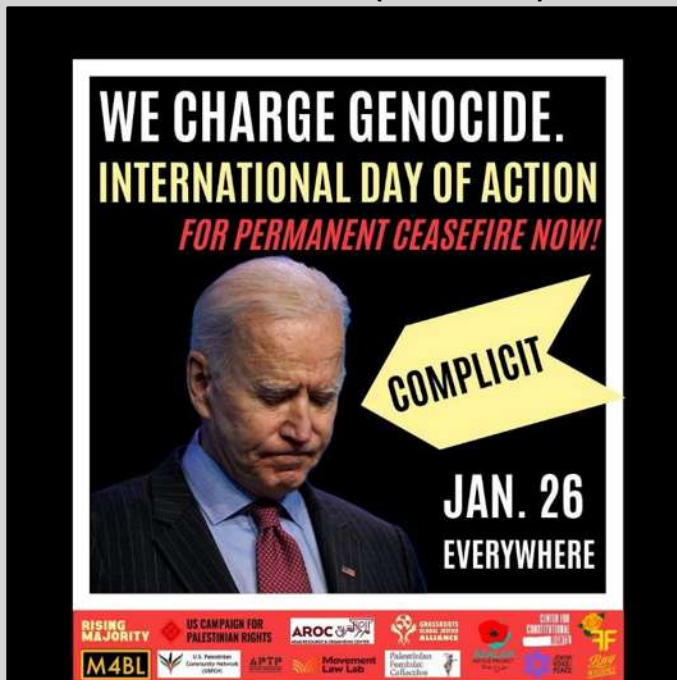

### Kevin "Rashid" Johnson is fighting for his life. Feb 3

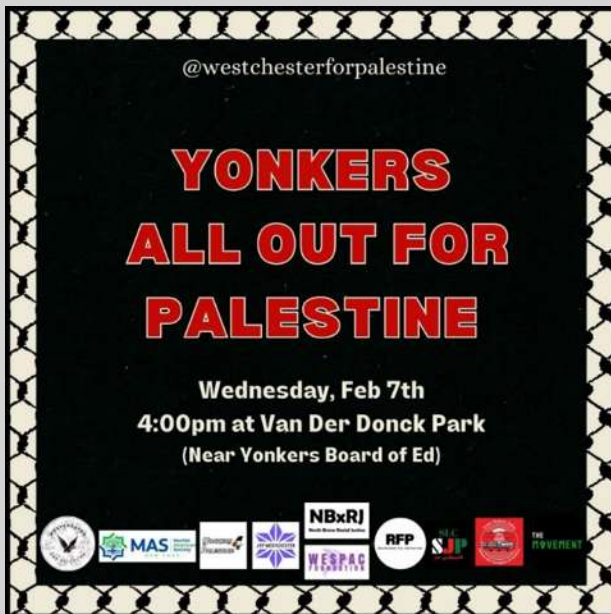
"Kevin "Rashid" Johnson has been leading a Hunger Strike inside Red Onion State Prison since December 26th to protest the prison's use of solitary confinement inside. He has missed close to 100 meals. This week, prison officials took him to court to declare him incompetent. So that he could be force fed. Rashid argued in court and the judge refused the prison's request. Rashid represented himself in Wise/Norton District Court House VA and won. Rashid has stated that he will continue to refuse food until he is guaranteed adequate and necessary healthcare. As of this past week, the VADOC has removed Rashid's inmate record and number from their system. He has presumably been transferred. They are trying to disappear Rashid from his supporters and his attorneys. "Rashid is incredible and inspiring. His demands reveal his strength in the face of the state's violence. We need to show up for him so his care is provided and that others are not subjected to violations of their 8th amendment rights to basic, necessary medical care." -Noelle Hanrahan, Prison Radio. You can still call the VADOC and DEMAND that Rashid be allowed to remain close to a major medical facility. He needs to be allowed to stay in either Sussex I or Buckingham, on the east side of the state. Red Onion is far on the west side of Virginia. If he is sent back it will be impossible for Rashid to access his care.

### **Judge rejects motion to dismiss | Hands Off Uhuru! Jan 30**

**Fed judge rejects Uhuru 3's Motion to Dismiss; Trial date expected to be set in February**

On Friday, January 26, 2024 U.S. Magistrate Judge Anthony Porcelli in the federal district court of Tampa, Florida filed an order recommending that District Judge William Jung deny the Uhuru 3's [motion for dismissal](#) of the bogus charges against Uhuru Movement founder and Black Liberation leader Chairman Omali Yeshitela, along with Penny Hess and Jesse Nevel, two white solidarity organizers with the Uhuru Movement.

Last year the U.S. federal government indicted the Uhuru 3 on the absurd charges that Chairman Omali Yeshitela and the Uhuru Movement's 50 year struggle for Black freedom suddenly became a "Russian-led conspiracy." The indictment came nine months after the violent military-style multi-city FBI raids on seven

homes and offices of the Uhuru Movement on July 29, 2022. The Uhuru 3 attorneys' motion for dismissal called for the baseless charges to be dismissed on the grounds that they violate the First Amendment right to freedom of speech. The case is expected to go to trial later this year. Dates for the trial are expected to be set at a status hearing in February. "The U.S. government has put us in the position of having to fight for the free speech that they claim is the cornerstone of U.S. democracy," said Chairman Omali Yeshitela.



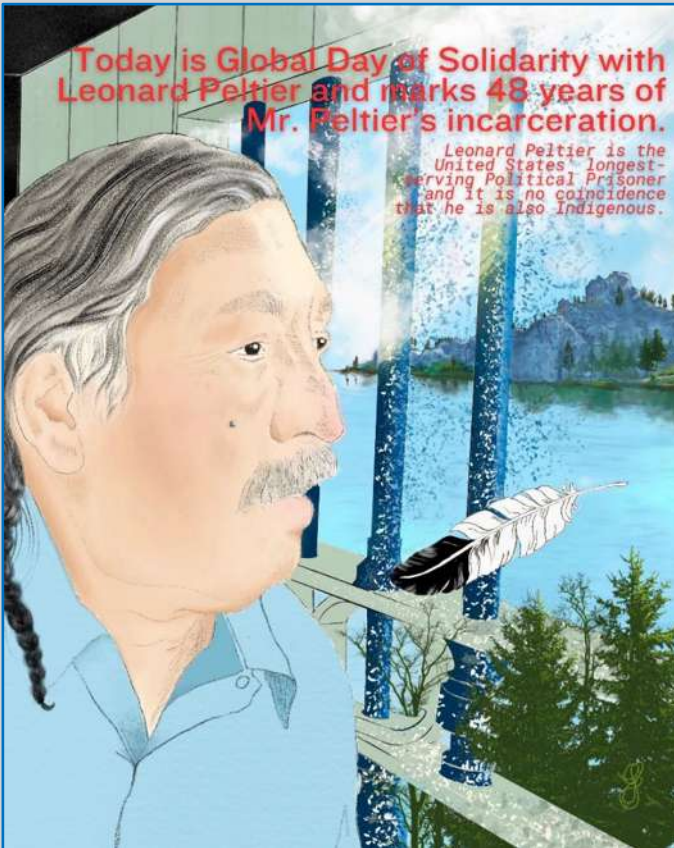

## Honoring Leonard Peltier on Global Day of Solidarity Feb 7



"[Today is Global Day of Solidarity with Leonard Peltier and marks 48 years of Mr. Peltier's incarceration.](#) On this day in 1976, the FBI arrested and extradited Leonard Peltier from Canada,

violating international treaty obligations and using improper tactics including fabricated evidence obtained by pressuring and terrorizing an Indigenous woman into writing a witness affidavit; the person who signed the affidavit has since recanted. Leonard Peltier is the United States' longest-serving Political Prisoner and it is no coincidence that he is also Indigenous. The Water Protector Legal Collective stands in unity with advocates worldwide in reiterating the call for President Biden to grant immediate clemency to 79-year-old Indigenous (Turtle Mountain Band of Chippewa/Dakota/Lakota) activist Leonard Peltier. Leonard Peltier has endured time in solitary confinement, serving two life sentences for a crime he did not commit. Despite serious concerns about the fairness of his trial, Leonard has been consistently denied parole. In October 2023, during the United Nations review of U.S. compliance with international human rights obligations under the

ICCPR, Vice Chair of the Human Rights Committee, Dr. Changrok Soh acknowledged how Death by Incarceration continues to disproportionately impact Black and Indigenous Peoples in the US, including Mr. Peltier. While in Geneva for the U.S. review, WPLC authored and submitted a [Joint Statement regarding the Release and Freedom of Political Prisoner, Leonard Peltier](#) to the U.S. government. The letter – signed by Water Protector Legal Collective, the Center for Constitutional Rights, the Abolitionist Law Center, among others – calls for the United States to definitively and concretely recognize the need to right a historical wrong and free Leonard Peltier. We urge the administration to uphold its commitment to human rights and justice by promptly granting Leonard Peltier clemency on humanitarian grounds." Source: Email.

## **The Spirit of Mandela Coalition & the Peoples' Senate Organizing Committee**

**DID YOU KNOW that in 2021, the U.S was found GUILTY  
of five accounts of genocide against Black, Brown, and Indigenous people??**

**Dear Friend and Fellow Freedom Fighter,**

The Spirit of Mandela Coalition, following up on the October 2021 International Tribunal verdict finding the US Guilty of Genocide against Black, Brown, and Indigenous people (see full verdict [HERE](#)), is calling for the building of a new mass grassroots formation: The Peoples' Senate. The people need to govern and represent themselves in combating genocide and addressing their right to a just and humane existence. Our vision is for the Peoples' Senate, organized directly by our oppressed communities, to grow into a body which will serve that purpose.

Today our communities face the most egregious violations of our human rights since the civil rights and Black power movements of the 1960s and '70s. Conditions we are living under include random mass shootings, right-wing vigilante attacks, police violence and murder, environmental racism, the reassertion of "states rights" (the "right" of states to ignore basic human rights), and healthcare racism. The US government dangerously scapegoats immigrants; causes destabilization, extreme violence, bombing, and killing of Black, Brown, Indigenous, and poor people all over the globe – and spends billions of dollars to do it; and keeps hundreds of thousands of people living in homelessness and poverty in the US. Our communities are facing targeted attacks against voting rights, workers' rights, women's rights, and Indigenous Peoples' rights as right-wing elected officials and appointed judges roll back decades of hard-won battles for justice. While out-voting right-wing candidates during elections is important, voting alone will not be enough. We must organize to put more pressure on the system for major change.

The US Congress and Senate are representatives of the rich and powerful. They refuse to address the necessity for universal healthcare or a sound nationwide infrastructure providing access to clean water and other necessities. Corporations ignore and violate the needs of the planet while evading their fair share of taxes. US prisons are filled with Black, Brown, Indigenous, and poor people, many incarcerated for crimes they did not commit and/or serving sentences that far outweigh whatever criminal acts they may have committed. The oppressed national communities of Black, Brown, and Indigenous peoples all have political prisoners and prisoners of war incarcerated since the 1960s until today, who have fought for our liberation and are being held in prison unjustly or only released when near death. We want them all freed now!

Building our own Peoples' Senate will enable us to organize locally from a position of strength and connect local activists with others, in other parts of the country, who may be pursuing similar goals while electing "Senators" who are mandated to represent our interests and demands. A Peoples' Senate can fight for changes that protect and ensure our right to vote, our right to control our own bodies, our right to live free from discrimination as LGBTQ+ people, our rights to living wages and safe working conditions, our rights to sovereignty and dignity, and our rights to live free from state violence and abuse.
